The federal solar tax credit equals 30% of the solar system's costs, reducing the taxpayer's federal income tax liability by that amount.

Who will receive a \$7 billion solar grant?

Washington – Today, April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

Who qualifies for the federal solar tax credit?

To qualify for the federal solar tax credit, the taxpayer must own the solar energy system. Those in a lease or a power purchase agreement (PPA) with the solar installer aren't eligible for the tax credit, as they aren't considered



system owners. Additionally, the taxpayer's tax liability has to cover the amount of the credit.

Are solar panels tax deductible?

The federal solar investment tax credit currently lets you claim 30% of your total solar system costs as a credit when you file taxes. Some places also offer tax credits that can reduce what you owe on state taxes. Property tax exemptions: Many states exclude the added home value from solar panel installations when calculating your property taxes.


